### **DSCU Primer**

The Defense Security Cooperation University (DSCU) is one of five directorates reporting to the Director of the Defense Security Cooperation Agency (DSCA). DSCA's mission is to advance U.S. defense and foreign policy interests by building the capacity of foreign partners in order to encourage and enable allies and partners to respond to shared challenges.

In 2019, DSCA stood up DSCU with the headquarters in the National Capital Region (NCR). DSCU is a team of teams. Our geographically separated and cross-functional components work in concert to create synergies that benefit students, strategic partners, and the National Defense Strategy. In collaboration with the rest of DSCA, the University plans for and responds to the real-world challenges and requirements of those we serve. DSCU's NCR HQ consists of the following elements:

- Strategic Workforce Programs Directorate—focused on the Security Cooperation Workforce Development Program and Security Cooperation Organization personnel (SCO) Management Program.
- Institutional Capacity Building (ICB) Directorate—focused on the planning, resourcing, and execution of ICB policy and programs, the advancement of ICB as a practice, and the professionalization and development of the ICB workforce.
- Security Cooperation Research and Lessons Learned Institute—which builds the intellectual foundations and promotes learning to improve the practice and advance the field of Security Cooperation.
- International Military Training and Education (IMTE) Division—which supports and manages programs and implements policies for Title 10/22-funded international military training and education activities.
- Irregular Warfare Center (IWC) As part of its role as Executive Agent, as mandated in NDAA 23, DSCU stood up the IWC which reached initial operation capacity on October 15, 2022. The IWC serves as the central mechanism for developing the Department of Defense's (DoD) irregular warfare knowledge and advancing the Department's understanding of irregular warfare concepts and doctrine in collaboration with key allies and partners.

DSCU's School of Security Cooperation Studies (SSCS) in Dayton, Ohio, supports DSCA's mission of training, educating, and providing for the long-term development of the Security Cooperation workforce.

DSCU's recently established College of Strategic Security Cooperation (CSSC) located in the National Capital Region is focused on higher-level Security Cooperation education as well as functional and regional studies.

DSCU's Defense Institute of International Legal Studies (DIILS) in Newport, Rhode Island, advances U.S. national security and foreign policy interests by building the capacity of foreign security forces to respond to shared security challenges in a responsible, accountable, and legally compliant manner through activities that promote the rule of law, enhance compliance with human rights and international humanitarian law, and support effective and responsible democratic governance.

DSCU's Institute for Security Governance (ISG) in Monterey, California, is the DoD's leading implementer for ICB and one of its strategic international schoolhouses. ISG is charged with building partner institutional capacity and capability through tailored advising, education, and professional development programs grounded in American values and approaches.

Item 1: Research Agenda

Based on consultations with a variety of stakeholders, DSCU produced a research agendaa to build the body of knowledge on Security Cooperation and help professionalize the U.S. Security Cooperation workforce. The research agenda, which will be formally released to the community in the coming weeks includes topics and ongoing debates meant to spark dialogue, debate, evidence-gathering, and theory development around Security Cooperation strategy, practice, and around Security Cooperation strategy and practice.

Item 2: Lessons Learned

As directed by the Secretary of Defense in the National Defense Strategy, the DSCU's Security Cooperation Research and Lessons Learned Institute is operationalizing its team as the Lessons Learned capability for the entire Security Cooperation enterprise. DSCU is uniquely positioned to gather and analyze data, and identify and disseminate best practices because we:

- Are a neutral and expert team not consumed by current operations
- Have ability to examine the response across the Security Cooperation enterprise
- Have the connections with other researchers in and out of government

### **Diversity: LEAD Foward**

Founded in the summer of 2020 as a grassroots effort to provide a space for listening and learning, LEAD Forward is now DSCU's Diversity, Equity, Inclusion, and Accessibility (DEIA) Council. LEAD Forward's charter was signed by DSCU's President in September 2022. The charter's mission states, in part, that LEAD Forward aims to promote an ethos of diversity, equity, inclusion, and accessibility, with a scope to advance and support the development of DEIA competencies at the individual, unit, and institutional levels across DSCU.
